I am emailing this morning to inform you of the upcoming community board meeting being held by Manhattan Community Board 4, at which we will be presenting on the intended new liquor license at 350 W. 39<sup>th</sup> Street (Hyatt Place Hotel). The new license will take the place of the existing liquor license and the license will be held by NY 39th Street LLC, NY 39th Street Operating LLC & TB2-39 LLC. The hotel will operate 24 hours a day, however it is the intention of the applicant to keep the kitchen open from 6 am until 12 pm.

The hotel will operate very similarly as it does under its current liquor license. The one change that is occurring is the outdoor patio will be enclosed by a roll-o-cover and guests will be permitted to consume food and beverage on the enclosed patio. A virtual tour is taking place with the bord members and a sound study has been conducted to ensure the space will not adversely effect its neighbors. No doors or windows will be open and there will be no music on the enclosed outdoor space.
