Re: CB4 Request for Evaluation of 550 West 20th Street

Dear Chair Carroll:

Manhattan Community Board 4 (CB4) asks for prompt action to our June 21, 2013 Request for Evaluation of 550 West 20th Street, originally the Seamen's House YMCA and later the Bayview Correctional Facility. **The building's lack of landmark protection is now an urgent concern.** At its full Board meeting of October 6, 2022, MCB4, on the recommendation of the Chelsea Land Use Committee, voted 37 in favor, 0 opposed, 0 abstaining, and 0 present but not eligible, to approve this letter.

On February 26, 2019, MCB4 sent a second letter to the Commission seeking a response to our 2013 Request for Evaluation. LPC wrote back on February 28, 2019, only to say, "the agency will review the material and keep you informed of the process." We've heard nothing from LPC in the three and a half years since that response. It is now over nine years since our initial request without any meaningful action from the Commission.

Currently, the Empire State Development Corporation (ESD) is looking into potentially converting the building into supportive housing as part of the Penn Station Redevelopment Plan. This follows the failure to re-develop the property by an entity approved by ESD in 2016, which has withdrawn its application.

Recently, the New York State Office of General Services conducted work on the building. Many of the building's distinctive, polychrome terra-cotta elements have been replaced with conventional brickwork. New York State Historic Preservation Office (SHPO) oversight and notification is required on any work on any building declared eligible for listing on the National Register of Historic Places. The Seamen's YMCA was

declared eligible during the creation of the Special West Chelsea Zoning District. SHPO has reported that it was unaware of the work by the Office of General Services.

Actions by the Office of General Services call for the added layer of oversight that New York City landmark designation would provide.

The terra-cotta elements are a key to the design intent of the building's notable architects, Shreve, Lamb & Harmon, who designed the Empire State Building at about the same time. Their stylized ship-prow imagery speaks of the building's original use as the Seamen's House YMCA and Chelsea's history as a working waterfront. As noted in our 2013 Request for Evaluation, the building's New York City landmark designation would be consistent with the earlier designations of the American Seamen's Friend Society Sailors' Home and Institute at 505-507 West Street and the Keller Hotel at 150 Barrow Street, structures similarly built to serve sailors and embodying the community's history as "the heart of the busiest section of the Port of New York" to quote the Keller Hotel's designation report.

The community has had to rely on local elected officials to take action to ensure protection of this community asset. Instead, LPC should deliver on its mandate to protect our historic assets.

We would appreciate immediate action on our Request for Evaluation before further work is done to this building.

Former Seamen's House YMCA at 550 West 20th Street:

For Landmark Designation

Dear Chair Tierney:

Manhattan Community Board 4 strongly urges the Landmarks Preservation Commission to designate the Seamen's House YMCA at 550 West 20th Street in Chelsea as a New York City Landmark as soon as possible.

The building is under imminent threat. It served as a YMCA dedicated to seamen until 1966 and later as the Bayview Correctional Facility. The Bayview facility is slated to close under New York State's Fiscal Year 2013-14 Budget. The Governor's Fiscal Year 2013-14 Executive Budget Briefing Book anticipated proceeds from the sale of Bayview in Fiscal Year 2014-15 and media accounts have recently reported that Empire State Development may put the facility up for sale within weeks.

If ESD goes forward with the sale, current development pressures in Chelsea will almost certainly result in demolition of the building and its replacement by new construction.

The only effective protection for the Seamen's House YMCA is prompt action by the Landmarks Preservation Commission to designate the building as a New York City Landmark. The process of disposal to private ownership almost certainly presents a window of time which would allow New York City Landmark designation. We believe designation is fully warranted on the merits of the building's architecture and character defining embodiment of neighborhood history. The Landmarks Committee of Community Board 4 has begun documenting the building and its history in support of a Request for Evaluation which it intends to submit imminently. This information should be an effective starting point for designation.

The Seamen's House YMCA was designed by the notable firm of Shreve, Lamb & Harmon, architects of the Empire State Building, and built in 1930-32. With the American Seamen's Friend Society and the Seamen's Christian Association, the YMCA was then one of three seamen's welfare organizations near each other on the Greenwich Village-Chelsea waterfront. Landmark designation of the Seamen's House YMCA would be consistent with the designation in 2000 of the American Seamen's Friend Society Sailors' Home and Institute at 505-507 West Street, and the 2007 designation of the Keller Hotel at 150 Barrow Street. The latter is cited in its designation report as "a significant reminder of the era when the Port of New York was one of the world's busiest and the section of the Hudson River between Christopher and 23rd Streets was the heart of the busiest section of the Port of New York," a description which applies no less to the Seamen's House YMCA.

The building exterior is in excellent condition. It has been significantly altered only by the introduction of a steel superstructure for a rooftop fence. This addition, which detracts from the compositional interest of the building's roofline, could easily be removed. Primarily clad in brick, the building has handsome art deco massing, a distinctive corner entrance and scores of polychrome terra cotta medallions featuring nautical themes as well as modeled terra cotta window surrounds and string courses.






















