  - COVID impact on district staffing: 1/3 of the command had contracted Covid but most have returned

    - COVID impact on district staffing: At the beginning of the year had 100 officers out but only 10 officers out currently due to covid

- COVID impact on district staffing: **Beginning of the year only 2** staffers out with covid

- Inspection of 412 West 46th Street: DOB & HPD had a joint inspection and waiting for a report on it
- Stop Work Orders
  - 317-319 West 35th Street: Stop work order remains
  - 343 West 47th Street: The engineer for the property sent a letter saying to building is unsound and need to be demolished but DOB went out with the engineer and found the building to be sound.
- New: Possible illegal use at 233 West 20th Street: Inspection was done on Jan 10<sup>th</sup> and no violations found. Jan 12<sup>th</sup> tried to gain access again but was not able to do so

### **DOHMH:**

- Inspections team have been redeployed to assist in Key to NYC enforcement so all of our 311 complaints are being triaged based on urgency and our folks are working as best as they can to get to their usual work.
- The State has issued new guidance around quarantine https://coronavirus.health.ny.gov/new-york-state-contact-tracing

- Everyone is encouraged to get their booster shot and to continue wearing a mask indoors especially when social distancing cannot be maintained.

    - MED 609 Water Main Installation 9<sup>th</sup> Ave West 50s Street -Wayne Brown – Completion Date: November 2021: The project is on hold until March or April until a decision is made about sidewalk cafes
    - MED598B Trunk Water Main West 30<sup>th</sup> Street Mike Whitfield – Completion Date: Summer 2022: The contractor completely move off W 30<sup>th</sup> Street/Dyer Avenue. Still working on the westside of 9<sup>th</sup> Avenue/W 33<sup>rd</sup> St.
    - MED-645 Water Main Installation 10<sup>th</sup>/11<sup>th</sup> Ave and West 20<sup>th</sup> St./West 21 Str – Sayda Noboa-Torres – Completion Date: Spring 2022: Done on W 21<sup>st</sup> St. Will start construction on W 20<sup>th</sup> St and moving equipment there
    - HWMP2020 Gansevoort Area Reconstruction Sofia Noboa – Completion Date: Spring 2022: Gas main installation has been completed.

• NYC Free Tax Prep 2022 Season:

Families with income of \$72,000 or less and single filers with income of \$50,000 or less in 2021 can use NYC Free Tax Prep to file for free.

#### NYC Paid Safe and Sick leave:

COVID-19 and Paid Sick Leave. Workers who have COVID-19 or were in contact with someone with COVID-19 can get sick leave (time off) regardless of immigration status. State and local laws let workers take time off to care for themselves or a family member.

SPECIAL LEAVE FOR THE COVID-19 VACCINE. Workers get additional leave under CITY law to get their kids vaccinated. Workers get 4 additional hours of sick leave for EACH child; and EACH vaccine injection. Employers cannot mistreat or punish workers for using or asking for sick leave. Download a summary of the paid sick leave laws in English. Translations will be available soon. Visit nyc.gov/workers for more information. Delivery Workers:

NYC recently passed a suite of new legislation regulating the online thirdparty food delivery service ("delivery apps") industry in NYC and providing legal workplace protections for delivery workers. See a summary of the rights below or download our palm card in English. Note we will have additional translations soon. Starting January 24, 2022: (only if you work for apps that take customer orders directly)

- Apps must tell you how much the customer tips for each delivery.
- Apps must tell you your total pay and tips for the previous day.

• You may have better access to restaurant bathrooms when you pick up orders.

Starting April 22, 2022:

• You have more control over your deliveries. You can limit how far you will go from restaurants and refuse to use bridges or tunnels.

• Apps must tell you route details before you accept a delivery. Must include address for pickup, estimated time and distance for trip, tip if known, pay.

• Apps must pay you at least once a week. Apps cannot charge a fee to process your payment.

• Apps must give you a free insulated food delivery bag after 6 deliveries.

**Starting January 1, 2023:** 

• Apps must pay you the new minimum pay rate that the City will set. Beginning January 24, 2022, workers can file a complaint about apps that do not provide required disclosures or restaurants that do not provide bathroom access. To file a complaint, email OLPS@dca.nyc.gov.
