Good Afternoon Everyone!
This is Robert Guarino from Marseille on 44th St and 9th Avenue. I am writing today to tell you about our intentions to re-concept our basement bar, formally "Reunion."

As you may be aware, we have always operated a bar in the basement space below our fine dining restaurant Marseille. This bar is entered on 44th St through the service entrance of the Film Center Building.

For the last 10 years until Covid, we operated this bar as "Reunion." Reunion was a fun, laid-back surfthemed bar serving great drinks, and a food menu prepared by the Marseille kitchen. Unfortunately, we closed during COVID and have not felt it was the right time to re-open the bar until now.

Given our deep roots in the neighborhood and our desire to be here for many years to come, we want to take the opportunity to re-brand the bar for the future. Our new concept will be called "The Friki Tiki." We are creating this concept in collaboration with Broadway producer Greg Nobile and Architect Eamon Roche. Greg and Eamon operate the original Friki Tiki on the Long Island Sound in Branford, CT.

Like Reunion, the Friki Tiki will be a fun bar with great food and drinks that will cater to the neighborhood, after-work and Broadway clientele. We are re-decorating the space and adding a small stage and a piano to accommodate a live piano show. We anticipate there will be one show nightly from 9:00 to Midnight. Total occupancy will remain at 70 people. We will not be changing operating hours, and will be open no later than 2 AM on any day.

Given the location of the bar in the basement of a commercial building, we do not anticipate any disturbance to our neighbors. Since 2001, we have always worked hard to be upstanding members of our beloved Hell's Kitchen community.

We will be discussing the proposed change at the CB4 meeting on Tuesday, October 11. Please feel free to reach out to me beforehand if you have any questions.
