Remarks from Elected Officials and Representatives			
Manhattan District Attorney Alvin Bragg	 Gun violence: City-wide, shootings and homicides decreased in 2022 compared to 2021 by 20% Robberies and grand larceny auto crimes in our district are also decreasing Hate crimes: increased in 2022 compared to 2021, so our office has grown in size and our prosecutions of hate crimes are up 20%. The biggest uptick in hate crimes is against the following three groups of people: LGBTQ, AAPI and Jewish people. Housing and Tenant Protection Unit: we started it in 2022 and already it is very busy prosecuting developers and landlords who are violating the law. The unit also has a hotline to call to report landlords and developers who are breaking the law. Smoke shops operating without a license: we've sent letters to 400 in the city, putting them on notice that the DA's office can initiate commercial evictions if they are operating without a license. 		

Deputy Manhattan Borough President Keisha Sutton- James	 Mental health initiatives: Community Navigators and Courtroom Navigators. Harlem Hub: great pilot program focused on 125th Street that addressed the combination of open-air drug use, mental health issues and homelessness. This program should be scaled up and brought to other neighborhoods. Million more trees initiative: thanks to CB4's WPE for drafting a letter to support our initiative. We hope the letter is approved tonight. Community Board Application Process: open now, and will close on March 17th. Please help us spread the word1 Composting: we are working with DSNY to try to roll out more composting bins.
City Council Member Gale Brewer	 Glad to be working with DA Bragg to address illegal cannabis sales Super excited about pilot program at Amsterdam Houses to hire people to canvas the community to identify concerns and possible solutions E-batteries: proposed legislation to ban the sale of secondary e-batteries Advocating for evictions only with good cause Clinton Towers has lots of issues ID NYC application process needs to be improved
State Senator Hoylman-Sigal	 Introduced legislation that will require social media platforms to clearly publicize their content moderation practices. Proud to be part of the group that fought for expanded hours at the Midtown Community Court. Introduced legislation to ensure that eviction proceedings are put on hold if a tenant doesn't have legal counsel. Working on the issue of good cause eviction Also focused on LGBTQ nightlife issues, including recent thefts.
NYC Mayor Adams' representative Robin Forst	 Summer Youth Employment Program: deadline is the end of March. This year the program will include SYEP Pride. Free tax prep being offered throughout NYC. One-time amnesty program offered right now for property owners who are in arrears for overdue interest on their property loans.
State Senator Liz Krueger's rep Dana Schmerzler	 The Senator is Chair of the Senate Finance Committee so she is very involved in the state budget negotiations and hearings. Also working on legislation re: climate crisis, lithium batteries and illicit cannabis sales
State Assemblymember Linda Rosenthal's rep Donna Shashoua	 Advocating for Housing Access Vouchers to be included in the state budget, similar to what is available in NJ and CT. Also advocating for legislation that would penalize landlords who overcharge tenants Universal Pre-K in NYC is in crisis, including the fact that Pre-K providers are not getting paid in a timely fashion. Affordable childcare is vitally important, so we are focused on it.
