Re: Liquor License Application for 50 Hudson Yards

To the Committee Chairs,

I am land use counsel to the owner of 50 Hudson Yards. I have been asked to respond to questions raised at the June 13, 2023 Business Licenses and Permits Committee meeting regarding applicable zoning regulations.

You asked how the proposed outdoor seating complies with applicable zoning. The proposed outdoor seating will occupy a portion of required sidewalk widening areas at the site. Pursuant to ZR Section 33-05, outdoor restaurant seating is permitted within a required sidewalk widening, subject to compliance with city council legislation establishing the Permanent Open Restaurants program and the rules promulgated by DOT to administer the program. This section of the Zoning Resolution states:

“Notwithstanding any other provisions of this Resolution, outdoor table service areas, associated with eating and drinking establishments, meeting all requirements set forth in legislation by the City Council and any subsequent rulemaking by an authorized agency shall be permitted within any required sidewalk widening areas.”

The City enacted this zoning provision in 2021 as part of the Open Restaurants zoning text amendment, which removed sidewalk café regulations from the Zoning Resolution in anticipation of the creation of the Permanent Open Restaurants program to be administered and enforced by DOT. The applicant will seek a license for a sidewalk café from DOT and comply with all other requirements of the Permanent Open Restaurants program.

You also asked whether an illuminated restaurant sign complies with applicable zoning. In the C6-4 district in which 50 Hudson Yards is located, zoning permits both non-illuminated and illuminated accessory signs (except flashing signs are not permitted within 100 feet of Hudson Boulevard). ZR §§ 32-644; 93-16. The zoning provides for a maximum total surface area of accessory signs of “five times the street frontage of the zoning lot, but in no event more than 500 square feet for interior or through lots or 500 square feet on each frontage for corner lots.” ZR § 32-644. The actual size and location of any accessory signs have not been determined.

50 Hudson Yards Ground Floor Restaurant

The restaurant on the ground floor of 50 Hudson Yards is located on the North-West corner of the building and will serve breakfast, lunch, brunch, and dinner. The restaurant will operate from 8AM – 12AM Monday – Friday, and 10AM – 12AM Saturday – Sunday.

The Mezzanine Bar is located on the mezzanine level within office lobby of 50 Hudson Yards and will serve coffees and pastries during the day, and alcoholic beverages and bar snacks in the evening.
