May 2022 Full Board Minutes

Meeting Date / Location	The Full Board met at 6:30pm on Wednesday, May 4, 2022, via Zoom webinar and was simultaneously live streamed on YouTube. It can be viewed at: https://www.youtube.com/watch?v=PatiRd11I9w
Presentation	<p>Presentation: Deputy Inspector John L. O'Connell from the Midtown North Precinct</p> <ul style="list-style-type: none"> • Deputy Inspector O'Connell is the new Commanding Officer of the Midtown North Precinct. He's focused on engagement and being accessible within the community, as well as addressing the perception of people not feeling safe in the neighborhood. • The precinct is experiencing a substantial increase in property crime, including grand larcenies and burglaries. Many perpetrators are stealing due to other underlying issues like drug addiction that they are trying to fund. • While the precinct has been addressing the crimes through an increase in arrests, the precinct is also trying to address root causes, including working with City resources and 3-11 to help people with mental health issues and referring those in need of treatment. • The precinct won't be receiving an increase in staffing from the Mayor's recent gun violence initiative, since it is not in the City's top 40 precincts for gun violence, but it does receive support from Critical Response Command (CRC, which covers high-profile areas) and Borough Patrol. The precinct could also be receiving new officers from the next Police Academy graduating class. • Apps that allow people to report crimes, e.g., the Citizen app, can spread false reports and may contribute to misperceptions of the level of crime in the neighborhood. • The Precinct's Community Precinct Council meeting is held on the 3rd Tuesday of each month at 7pm.
Presentation	<p>Presentation: Rachel Hutt, Senior Volunteer Recruitment Manager at iMentor</p> <ul style="list-style-type: none"> • iMentor matches high school students with long term one-on-one mentors. iMentor partners with public high schools, helping students through their junior and senior years of high school, and through college. • Many mentees are first-generation college students, 98% identify as students of color, and 70% speak an additional language beyond English. • iMentor high school partners include the Business of Sports School and Hudson High School of Learning Technologies within Manhattan Community District 4 (MCD4). • iMentor is actively recruiting 1,500 volunteers to begin in Fall 2022. Mentors should be age 21+ and be able to commute to the mentee's school at least one

	<p>evening a month. Being a mentor is a two-year commitment, with a monthly commitment of 2-4 hours.</p> <ul style="list-style-type: none"> Prospective mentors should visit www.imentor.org/volunteer. Select that you found out about iMentor via a Community Group/Organization, Manhattan Community Board 4.
Public Hearing	<p>Public Hearing: 9th Avenue Roadway Restoration and Upgrade Project</p> <ul style="list-style-type: none"> The Public Hearing was introduced by MCB4 Transportation Committee (TRANS) Co-Chair Christine Berthet. The reconstruction of the upper part of 9th Avenue in our district was postponed since 2020 due to the pandemic, but is now going to begin, with the addition of some benefits including sidewalk widening and relocation of the bike lane. However, the work will displace 34 dining sheds which need to be off the avenue between May and November this year.
Public Hearing Speakers	
Matt Birde	<p>Mr. Birde is the owner of Valhalla Bar on 54th Street and 9th Avenue. He has spoken to other merchants in the area and agrees the roadwork project will be ultimately beneficial; however, their concern is the timing of the project. Establishments are not yet back to pre-pandemic levels financially. May and June are typically the best months to offset revenue losses from January-February and July-August. He is hoping that the project could be pushed back to start in July to make up some revenue in May and June. The sheds, which have needed to be dismantled, also cost a lot of money to build. Mr. Birde is also concerned about the noise pollution and dust associated with construction.</p>

Public Session Speakers	
Kira Levy	<p>Ms. Levy spoke on behalf of the Hudson River Park Trust. She announced that the Hudson River Park 2022 event season will be live on their website tomorrow: https://hudsonriverpark.org/visit/events/. The Park is excited to bring back a full-scale summer season, which runs through November. Ms. Levy also encourages residents to sign-up for their email list to receive event announcements and calendar details.</p>
Catie Savage	<p>Ms. Savage announced that Manhattan Community Boathouse will be opening for free public kayaking on Saturdays and Sundays starting on Memorial Day Weekend. Reservations are encouraged, at https://www.manhattancommunityboathouse.org/. Weekday evening sessions may be added in the future as well.</p> <p>Ms. Savage, who is the Founder of the Hell’s Kitchen Litter Legion, also announced that the group will have a booth between 52nd and 53rd Streets at the 9th Avenue Food Festival. They will have games and zero-waste bags from the Department of Sanitation (DSNY).</p>
Susan Wallitt	<p>Ms. Wallitt lives at Penn South, on a high floor facing west 25th Street where the temporary dog park has opened. In recent weeks, disruptive noise from the dog park has increased substantially. Noise reverberates within the open space, and she is awoken by dogs barking prior to 8:30am. Mornings, lunch time and after work are the loudest. She would like something to be attached to walls around the dog park to absorb the sound and encourages reevaluating the dog park before any decision to make it permanent.</p>
Zazel Loven	<p>Ms. Loven is Chair of the Chelsea Waterside Park Association. She thanks the Board for considering the street co-naming for Mr. Robert Trentlyon. Ms. Loven encourages the Board to meet with the Department of Transportation (DOT) if co-naming is approved, in order to finalize its location.</p>

Lisa Wager	Ms. Wager is Director of Government and Community Relations at the Fashion Institute of Technology (FIT). The annual graduating students' exhibition will be on view from May 17 to May 29, and presents the work of over 600 FIT art and design students. The exhibition includes toy design, textile design, packaging design, graphic design, jewelry design, fashion design, accessory design and more. FIT is also hosting Summer Live, a precollege program for students in middle and high school, including hands-on learning opportunities taught by FIT faculty. Programs start from just a week long, and are offered either remotely or on campus. Registration is open at the FIT precollege registration webpage.
Shelli Rosen	Ms. Rosen voiced support for the new dog run (at Penn South). Dogs and families are happy. Users of the dog park are determined to be considerate to neighbors and are looking at ways to raise awareness of the problem of excessive barking in order to be responsive to concerns.

Remarks from Elected Officials and Representatives	
Deputy Borough President Keisha Sutton-James	<ul style="list-style-type: none"> • Manhattan Borough President Mark Levine and several members of his office attended the rally in Foley Square on May 3, 2022, to express their dismay at the leaked Supreme Court draft opinion re: Roe v. Wade. MBP Levine called the draft opinion a “breathtaking setback and a brutal blow to millions of women...” • COVID continues to pose significant health risks. NYC recently moved into the yellow (medium) risk category as the numbers of COVID patients are rising. There are approximately 2,500 new COVID cases a day in the city. We continue to recommend that all eligible people get their booster shots and wear masks indoors in public settings. • A record number of applications were received for Community Board seats. Almost 900 applications were received for the 12 Community Boards. Applicants should hear responses by next week. A huge thanks to all who applied! • NYC is notorious for lacking public restrooms. This is an issue of equity, public health, sanitation and tourism. MPB Levine is advocating for a report that will address the feasibility of a public bathroom in every zip code across all 5 boroughs. • MBP Levine’s office partners with an organization called Uptown Wagon, which is a collective of neighbors who meet in upper Manhattan to distribute meals and supplies to neighbors experiencing homelessness. The next distribution event will be on May 18th at MBP Levine’s 125th street office.
Councilmember Erik Bottcher	<ul style="list-style-type: none"> • Councilmember Erik Bottcher’s office organized a rally and press conference in front of 410 and 412 West 46th Street, which are both owned by the same landlord. The goal was to call attention to the abominable conditions that the tenants are living in, and to put pressure on the landlord to right the many wrongs. The NYC Department of Housing Preservation and Development (HPD) is trying to take control of 410 West 46th Street so that it can do the repairs itself and then bill the owner. • The dog run at Chelsea Waterside Park has been closed for renovations, so a temporary dog run has been opened at Penn South in an underutilized area

	<p>between two buildings. It will be up to the community to decide if this dog run should be permanent.</p> <ul style="list-style-type: none"> • Councilmember Bottcher’s campaign to get more people to clean up after their dogs seems to be gaining traction. He asked for additional enforcement agents to be assigned to the District and they have been issuing \$250 tickets to people who fail to clean up after their dogs. • Mr. Bottcher has visited every school in his District to get an inventory of their capital needs. • The councilmember has also done walk-throughs of the NYCHA buildings and met with community leaders and police representatives to talk about the public safety issues in NYCHA housing. • The scaffolding on 21st and 8th Ave. should be removed by the end of the summer, according to the landlord. Bottcher’s office will keep an eye to ensure that it comes down then. • Bottcher’s office has also introduced a resolution requiring the NYC Department of Education to teach bike safety in schools. New York State also mandates that bike safety is taught in schools. • Bottcher’s office is also introducing a resolution to double the fines on vehicles for excessive noise (e.g. mufflers, exhaust, honking).
<p>Congressmember Jerrold Nadler</p>	<p>Congressmember Nadler provided the following comments and updates:</p> <ul style="list-style-type: none"> • <u>Reproductive rights</u>: Last night, an initial draft opinion to overturn Roe v. Wade was leaked. If this report proves true, this decision will represent an unconscionable rollback of fundamental rights—rights to equality, autonomy, and reproductive health—for all people living in the U.S. The right to have an abortion is fundamental to women’s health, equality, autonomy, and personal liberty. Making decisions about when and how to start a family is central to women’s lives. If women cannot make decisions about their reproductive health, they cannot make decisions about starting a career, going to school, opening a business, and planning their lives. Last year, the House voted to pass the Women’s Health Protection Act, which would codify the protections in Roe v. Wade and block all ongoing and future attempts to eliminate a woman’s right to safe and legal abortion care. The Senate can and must end the filibuster and pass this legislation to end the decades long war on abortion and on women’s underlying freedom to control their own lives. I will keep fighting to ensure that every person, regardless of state of residence, income, race, or any other factor, retains their constitutional right to access abortion. • <u>Ukraine</u>: I am proud that Congress has already delivered \$13.6 billion in humanitarian, military and economic support for Ukraine – which is being delivered with extraordinary speed, every day, to those in need on the ground in Ukraine. Congress has also successfully passed into law critical legislation to punish and weaken Russia – including by holding it accountable for its war crimes, cut off the engine of its war economy, and isolate it from the world

	<p>economy. Congress and the Biden Administration, together with our allies and partners, are committed to standing with the people of Ukraine as they courageously defend themselves and their nation against Putin’s horrific war. As Chair of the Congressional Jewish Caucus, I will continue to hold Putin and his cronies responsible for the blatant antisemitism that is being used to justify his cruel and unnecessary invasion.</p> <ul style="list-style-type: none"> • Helicopters: New York City has one of the highest rates of helicopter use in the world. Furthermore, New York City is one of the most densely populated cities in the United States, exponentially increasing the potential dangers of a helicopter accident in our city. There is no justification for allowing tourists to joy-ride through our skies, endangering people below and adding to the heavy burden of noise pollution residents already endure. Commuter helicopter flights impose risks to the community that far outweigh any benefits to the very small number of people who use them. I have introduced two pieces of legislation this Congress to substantially reduce the number of non-essential helicopter flights over New York City. I plan to introduce two more bills over the next month to force the FAA to take action. I am also pleased to have included a provision in the Fiscal Year 2023 government spending bill that will require the FAA to initiate regulations addressing helicopter noise and safety issues above New York City within one year, unless the agency can demonstrate that the six voluntary measures it recommended in May have proven to be effective. • Redistricting: The New York State Court of Appeals has rejected the redistricted Congressional and State Senate maps and has appointed a Special Master to redraw these maps. We expect these new maps in the coming days. My top concern is ensuring that these maps keep communities of interest together and adhere to the Voting Rights Act. The primary, originally scheduled for June 28th, will be moved to August. I know a lot of people are out of town around then, so be sure to vote early or request an absentee ballot.

The MCB4 working group will meet about next steps tomorrow. ○ Sanitation Planning Working Group- The working group continues to meet with city agencies including the Department of City Planning (DCP) and the Manhattan and Bronx Solid Waste Advisory Boards (SWABs). • Other Small Meetings & Board Activities: <ul style="list-style-type: none"> ○ Chelsea Hell's Kitchen Land Use (CHKLU)- Continued meeting with owners of 343 West 47th Street and Department of Buildings (DOB). ○ MCB4 office is meeting with Department of Design and Construction (DDC) and Department of Environmental Protection (DEP) re Water Main Project MED 669 7th Ave from West 14th-34th Street. • MCB4 provided the following testimony: <ul style="list-style-type: none"> ○ Landmarks Preservation Commission (LPC) re: 417-419-421 West 20th Street and 442 West 22nd Street. ○ The City Planning Commission (CPC) held a public hearing as part of the Uniform Land Use Review Process (ULURP) for 806 9th Avenue (MTA Site); the Chair along with Board Members Joe Restuccia, JD Nolan and Paul Devlin submitted the board's formal testimony.
