Presentation

Ali Rasoulinejad, Chief of Staff of the New York City Districting Commission, presented to the Board to provide background on the NYC Districting Commission and its current work on City Council redistricting:

- The NYC Districting Commission is tasked with redrawing the City Council district maps based on the most recent U.S. Census. The City's population grew unevenly across the current districts, from a total of 8.2 million in 2010 to around 8.8 million in 2020, resulting in the need to reapportion districts. The largest population growth during these years came from Asian and Hispanic populations.
- Each of the 51 Council districts will now have an average population of 172,882 people; the district lines must be drawn such that the difference in population between the most and least populous districts does not exceed 5%.
- When drawing maps, the Commission must abide by the federal Voting Rights Act of 1965, which prohibits a map from denying or diluting the voting power of racial or language minorities. The City Charter also stipulates that districts must be contiguous and the Commission needs to (in order of priority): keep neighborhoods and communities intact, keep districts compact, limit crossover districts across boroughs, avoid splitting voters of the same political party for purposes of diminishing effective representation, and avoid oddly shaped districts.
- The Commission's timeframe for submitting a final Council redistricting plan to the City Clerk is Feb 7, 2023. Public Hearings were held from May to July in each borough, the Commission then released a preliminary plan, and now will be holding additional public hearings in August followed by the submission of a plan to the City Council on September 22. The Council can then approve or reject the plan; if the plan is rejected, that leads to an additional round of public hearings and a vote by the Commission members where 9 out of 15 Commissioners must vote to finalize the map for submission.

	Public Session Speakers										
Preeti Sodhi	Ms. Sodhi is Director of Community Engagement at the High Line. The High Line is focused on building community-responsive programming such as a new wellness progreatering to the needs of seniors and developed in partnership with Penn South Seniors. High Line also offers family programming tying into the ongoing "We Hold These Trut exhibition, and an "Art of Expression" teen program. The ¡Arriba! Latin dance night ha also returned to the High Line, with the next event in August.										
Tom Lunke	Mr. Lunke thanks the Board and Chelsea Land Use Committee for supporting the effort to landmark Former Colored School #4 on West 17 th Street and looks forward to continuing to work with the Board on continuing the effort.										
Irene Kelly	Ms. Kelly supports the Chelsea Land Use Committee letter to deny permission for the additions to 353 w. 20 th Street. She notes that the developer working on the project has not communicated with her about the construction and has already started work on the property even after the committee recommended denial of the permit.										
Lisa Wager	Ms. Wager is Director of Government and Community Relations at the Fashion Institution of Technology. The school is continuing progress on a new academic building, the school's first new building in nearly 50 years. Construction has already reached the 10 th floor. The building will be LEED Silver when completed.										
Pamela Wolff	Ms. Wolff echoed Mr. Lunke's support for the landmarking of Former Colored School #4. Ms. Wolff is also excited about the groundbreaking at 7 th Ave and 22 rd Street, Southwest Corner. Poorly maintained buildings at the location will be replaced with a new 9-story building that will be constructed in a manner contextual with the neighborhood and contain 26 affordable apartments. The 5 families that remained in the old buildings will be returning to the new building after construction.										
Eric K. Washington	Mr. Washington thanks the Chelsea Land Use Committee for its diligence in preparing the letter regarding Former Colored School #4 and supporting the landmarking project. An article about the building appeared last week on NBC News, which has already generated greater interest in the project including an invitation to the Tavis Smiley radio show and tweet from the NYC Municipal Archive.										
Melodie Bryant	Ms. Bryant is Founder and Manager of the West 22 nd Open Street. Ms. Bryant invited the Board and members of the public to an event on the street on September 4, from 10am-6pm. The event will illustrate to the Department of Transportation (DOT) what an open street can look like, with full street closure, seating, music, giveaways and more.										
Tom Lindon	Mr. Lindon is Vice President of Marketing & Events at Hudson River Park. The Park is hosting many upcoming events, including Healthy on the Hudson fitness programs, the Pier 84 jazz series, and the one-day Five Borough Festival of New York. The River Project wet lab research aquarium continues to offer environmental science programming. There are also upcoming Bollywood and Bhangra dance lessons, bike safety classes, and a Blues BBQ Festival in August. Visit HudsonRiverPark.org/Events for a full listing of upcoming events.										
Kamala Jefferson	Ms. Jefferson is a lifelong Chelsea resident. Ms. Jefferson observed many rats on the corner of 19 th Street and 8 th Avenue living under the outdoor dining area, and additional rats under Murray's. The platforms for outdoor dining have become a haven for rat communities. Ms. Jefferson is also concerned about 8 th Avenue between 17 th Street and 23 rd Street, as it is becoming filled with sex shops, drugs, prostitution and mentally ill people. She thinks the sex shops may be the root of the prostitution and drug issues, which have gotten worse in recent years.										

Remarks from Elected Officials and Representatives

Council Member Eric Bottcher

- Council Member Bottcher will be holding a redistricting town hall, with a
 presentation from the Districting Commission. Council District 3 had the largest
 population growth of any in the city, so it needs to shrink, but it's important for
 people to provide feedback on the need to modify it in a reasonable way.
- The Adams administration has resumed placing homeless people in hotels due to the shelter system being overwhelmed. There were a hundred single men placed in the Travel Inn on 42nd Street, and around 210 families in the Skyline Hotel. A large percentage of the families at the Skyline are asylum seekers from the Southern border. CM Bottcher anticipates more asylum seekers will be coming, and asserts that people in need of housing should be distributed throughout the district.
- The Council's Landmarks subcommittee voted on the MTA site (806 9th Avenue), which included several wins including new 2 and 3-bedroom affordable housing units at 80%, 100% and 120% of area median income (AMI), below-market rent for Stile's Market on street level, and improvements to the building design and façade. Property Manager for the building will be Lisa Management while HousingWorks will manage the affordable units. Lisa is working to prioritize residents with a connection to the district and long-term survivors of HIV/AIDS. Zoning text changes have been tailored to the specific site rather than extended to a larger area.
- 412 w. 46th Street has been ordered demolished by the Department of Buildings (DOB). The landlord allowed it to fall into disrepair.
- The MTA has added the 7 Train to its 20-year needs assessment planning document. It will be subject to study and potential inclusion in a future capital plan.
- DOT will be starting in the spring on construction of the 10th Avenue bike lane.
- CM Bottcher is also hosting a phone bank for marriage equality.

Assemblymember Dick Gottfried

- The Hell's Kitchen Neighborhood Coalition held a meeting with Manhattan District Attorney Bragg, New York Police Department (NYPD), Manhattan Community Board 4 (MCB4) and other community organizations about public safety. An issue that was brought up was the applicability of Medicaid payments for residential mental health placements. Assemblymember Gottfried will be looking into what New York should be asking the federal government for permission to cover with Medicaid.
- Following the Supreme Court overturning Roe v. Wade, the Assembly passed several bills to strengthen New York's role as a welcoming home for people in need of abortion services but live in states where access is now restricted.
- The century-old "Sullivan law", which requires a permit for concealed carry of a firearm, was struck down by the Supreme Court. The New York State legislature responded by banning the possession of guns in a long list of sites including public parks, healthcare facilities, schools, houses of worship, as well as Times Square.
- The Assemblymember has had around 30 bills passed by the legislature this year and are awaiting action by the Governor- this includes bills dealing with medical debt and noise from tourist helicopters.

	On Penn Station development, the Public Authorities Control Board (PACB) needs to unanimously approve any issuance of debt to fund the project. Each of the building sites within the project needs to go through the Empire State Development Board as well as the PACB in the future, which will provide additional opportunities for elected officials to secure more improvements. The Assemblymember and other elected officials have already achieved an increase in the affordable housing requirement, reductions in the total density of development, and inclusion of homeless and social services for people around the Station.
Evelin Collado, Manhattan Borough Director for Comptroller Brad Lander	 The Comptroller has rolled out a "resident-powered" survey of the New York City Housing Authority (NYCHA), to inform how the office will conduct audits of NYCHA. The Comptroller's office will be in touch with residents to solicit additional feedback. The survey is available on the Comptroller's website, in the newsroom section, and on social media. The Comptroller developed a new dashboard to track audits and their outcomes. So far, there have been 25 audits under Comptroller Lander. Evelin can be reached at Ecollad@comptroller.nyc.gov.
Yiyi Wang, MCB4 Liaison for Borough President Mark Levine	 The State Open Meeting Law suspension was extended through August 13, and the city extended its emergency order through August 24. COVID cases and hospitalizations are also up; people with COVID can reach out to 212-COVID19 to see if they are eligible for the treatment, Paxlovid. Monkeypox is also increasing in the city. The Borough President's office has requested more doses from the state, which itself needs to get more vaccines from the federal government. The city also should create a preregistration system for residents to sign up for vaccinations ahead of time. The State Department of Health also should increase access to testing, and the federal government should make more treatments available. The Manhattan Community Award Program is now open. It provides between \$5,000-\$7,500 to nonprofit organizations and public schools for programming or operational expenses. Each award is contracted through one of four city agencies: Aging, Corrections, Education and Health & Mental Hygiene. The Borough President's office has also set aside \$50,000 to fund composting programs throughout Manhattan. More information on these grants can be found on the Borough President's website. Clinton Hell's Kitchen Land Use Committee (CHKLU) Leadership met with representatives from the Sheffield Building, at 322 west 57th Street, regarding the maintenance of Balsley Park.
