## Presentation: NYPD 10th Precinct Commanding Officer Captain Robert Gault

Commanding Officer Gault provided an update on the 10<sup>th</sup> Precinct:

- The 10<sup>th</sup> Precinct has seen an increase in crime year-to-date, though it is doing better relative to other Manhattan South commands. In the 10<sup>th</sup>, crime is up 38% this year; the borough as a whole is up 46%.
- There have been increases in violent crimes including robberies and felony assaults, and particularly high increases in property crimes, including burglaries which are up 43% year-to-date.
- Arrests are also up significantly, particularly narcotics arrests which are up 59% year-to-date (169 narcotics arrests in the 10<sup>th</sup> Precinct year-to-date). Crimes are likely being driven by drugs, addiction and mental health issues.
- Hell's Kitchen and the area around 21<sup>st</sup> Street and 8<sup>th</sup> Avenue have been particular areas of concern.
- Contributing factors to the increases include remaining impacts of COVID, people leaving Manhattan, fewer people coming into the city for work, scaffolding and areas that are not properly lit, and people in need of mental health and addiction treatment and services.

## Special Presentation: State Senator Brad Hoylman

State Senator Brad Hoylman, on behalf of the New York State Senate, presented the Women of Distinction Award to Transportation Committee Co-Chair Christine Berthet in honor of her extensive service to our community. Ms. Berthet is a former Chair of MCB4, founder of the pedestrian advocacy group CHEKPEDS, and Chair of the Planning Committee of the Hudson Yards/Hell's Kitchen Alliance Business Improvement District. She has contributed to many citywide initiatives to improve pedestrian and street safety and air quality. 	Public Session Speakers
Molly Harris	Ms. Harris has lived on 22 <sup>nd</sup> Street for around 15 years. She has spoken to neighbors about the open street between 7 <sup>th</sup> and 8 <sup>th</sup> Avenue, which is currently closed 12 hours a day 7 days a week. Neighbors have been frustrated due to lack of access to cabs and Ubers, difficulties for disabled and senior residents, safety concerns as drivers need to move barriers, increased fire and police response times, and loss of business for the parking garage and dry cleaning service on the block. Ms. Harris encourages neighbors to look through comments on the Nextdoor app to view community concerns.
Bryan Sloane	Mr. Sloane is a Chelsea resident. He spoke about the deli/bodega at 215 8 <sup>th</sup> Avenue, the West 21 <sup>st</sup> Street Deli and Grocery, which is around 300 feet from PS11. There are significant narcotics and open container issues in front of this bodega. This bodega's liquor license to sell alcohol is expiring in December of this year. Mr. Sloan advocates for the denial of this license renewal, as well as the removal of the LinkNYC kiosks in front of and near this establishment.
Tom Lunke	Mr. Lunke reminded Board and community members of the upcoming Community Visioning Workshop on October 15 from noon to 2pm at St. Paul's German Evangelical Lutheran Church, at 315 west 22 <sup>nd</sup> Street between 8 <sup>th</sup> and 9 <sup>th</sup> Avenues. The gathering is to share thoughtful ideas for making West 22 <sup>nd</sup> Street a welcoming open street while maintaining vehicular access for sanitation and emergency vehicles, existing residents and businesses on the block. Joseph Neuhaus	Mr. Neuhaus has lived on west 22 <sup>nd</sup> Street between 8 <sup>th</sup> and 9 <sup>th</sup> Avenue for 25 years. He is concerned that the starting point for the discussion about the open street is the current closed hours and that additional closed hours are being proposed. He asserts that the open street was an experiment put in place during the pandemic and has not ultimately been successful. He encourages the Board and community members to maintain an open mind and consider the alternative of not having an open street.
Carin Ehrenberg	Ms. Ehrenberg has lived on west 22 <sup>nd</sup> Street between 8 <sup>th</sup> and 9 <sup>th</sup> Avenue for 16-17 years. She is an active member of Manhattan Community Board 2 and believes in open space. However, she asserts that the 22 <sup>nd</sup> open street presents a safety and pollution issue, and a problem for local residents who rely on cars. Ms. Ehrenberg doesn't believe that the open street, which made sense during the peak of the COVID pandemic, should be continued without additional study.
Bobby Vangelatos	Mr. Vangelatos is the new center manager at the Chelsea Recreation Center. He shared that the Center's programming session has recently started. This Saturday from 9am-12pm there's a breast cancer awareness fitness festival at the Center, which is free and includes fitness classes and giveaways. The Center offers programming for all ages, including fitness, sports clinics, painting, toddler classes and more. For more information, visit the NY Parks website or call 212-255-3705.
Lisa Wager	Ms. Wager is Director of Community and Government Relations at the Fashion Institute of Technology (FIT). A new show, "Resurgence" is opening on Monday in the FIT Art & Design Gallery; the show features work from around the world including textiles and jewelry created by FIT students, alumni and faculty. FIT student and faculty research is also winning grant funding including recent grants from the National Science Foundation for studying nutrition through gaming, a chemical recycling process for cotton, advancing wearable technology manufacturing, and funding for an electron microscope.

Andrea Ackerman	Ms. Ackerman lives on west 26 <sup>th</sup> street across from the Ainsworth and expressed support for the Board's draft letter recommending denial of the Ainsworth's liquor license. She asserted that the stipulations asked of the Ainsworth for the past 13 years have not been acted upon, so there isn't hope that any new stipulations will be followed.
District Manager Jesse Bodine	District Manager Bodine informed the board that he conducted a site visit with Village Care, on west 46 <sup>th</sup> Street. Village Care has a second floor open space that has been required to be vacated due to a dangerous wall of a neighboring building. He is working with Councilmember Bottcher's office and the Department of Buildings to get the owner to make improvements.

Matt Tighe, Chief of Staff for State Assemblymember Dick Gottfried	Casinos: Per legislation passed in the spring, three additional casinos may be sited New York state. There is talk of two potential sites in Manhattan: Times Square a Hudson Yards. Any site proposed in NYC will have to comply with local zoning and ULURP rules and must be approved by a 2/3 vote of a 6-member Advisory Committee that will be convened for each specific proposed site. The Advisory Committee will consist of one person appointed by each of the Governor, the May and the Borough President, and the other three members will be the State Senator, Assemblymember and City Council member for the District where the site is located. The State Commission will designate and pay for a Community Consulta who will work with local communities. The process is designed to be open and transparent. If a site is approved at the local level, then it will be referred to the N State Gaming Facility Location Board, which will determine the final three sites to be awarded a gaming license. <u>Redistricting</u> : the State Assembly maps will be redrawn next year, as a result of leg- challenges. <u>Smooth transition</u> : Assemblymember Gottfried is retiring at the end of this year, an he and the entire team are committed to a smooth transition to his successor.					
Jordan Feiner, MCB4 Liaison for City Council Member Erik Bottcher	<ul> <li><u>Participatory budgeting</u>: It's back! We will be holding meetings next week to generate ideas. We look forward to hearing everyone's ideas.</li> <li><u>Street Co-Namings</u>: We were honored to participate in two: <ol> <li>In Chelsea (at 23<sup>rd</sup> Street and 11<sup>th</sup> Ave.) for Robert Trentlyon, Chelsea activist and co-founder of the Chelsea Democratic Club.</li> <li>In Hell's Kitchen (at 42<sup>nd</sup> Street and Dyer Ave.) for Jim Houghton, the late founder of Signature Theater Company.</li> </ol> </li> <li><u>Homelessness</u>: Our office will be hosting a virtual panel on homelessness in NYC on Monday, Oct. 17 at 6:30 pm. We are going to fight to expand the array of services that such homeless outreach teams can offer.</li> <li><u>Family Shelters</u>: We have legislation with WIN calling for mental health</li> </ul>					
	professionals in all family shelters in the City. We also did a surprise visit to the					

	Skyline and we were pleased by what they are doing there and we will continue to work to make sure that the migrant families are being cared for.
	Sanitation: This is an important topic for our office. We were pleased to have the NYC Cleanup Corp. spend time last month in Chelsea helping clean the graffiti and address other sanitation issues.
Evelin Collado, Manhattan Borough Director for NYC Comptroller Brad Lander	<u>Climate Action:</u> Our office has created the NYC Climate Dashboard, which can be found on our website comptroller.nyc.gov. It tracks the City's progress at meeting its climate goals. We also wrote to the CEO of BlackRock asking the company to better align its actions with its climate commitments. BlackRock is the largest asset manager in the world, and the largest for three of the NYC pension funds.
	<u>Finance</u> : in conjunction with Mayor Adams, we have sold \$1.35 billion General Obligation Bonds, including fixed-rate Social Bonds. Money from the Social Bonds will help the City pay for many things, including more affordable housing.
	<u>NYCHA</u> : Our office has conducted surveys of NYCHA buildings as we prepare to audit NYCHA. One initial finding from the surveys is that a very large percentage of front doors are broken.
	Workers' Rights: Together with State Attorney General Letitia James, our office recovered \$3 million from a luxury residential property developer for denying workers prevailing wages and benefits.
Manhattan Borough President Mark Levine	Emergency Orders: The COVID Emergency Order has been extended through Oct. 21, and the Monkeypox Emergency Order extends through Oct. 26 <sup>th</sup> .
	<u>Migrants</u> : I am really proud of the way NYC has been embracing the migrants who have been arriving on buses sent from Texas. We need federal funds and potentially state funds to ensure their needs are met. These asylum-seekers are here legally and would really like to work but there is a bureaucratic backlog at the US Department of Homeland Security. Today, nine buses arrived – that's a record. Typically, it is 6-8 buses per day. It is very difficult to process so many people at the Port Authority Bus Terminal. Randalls Island and a cruise ship are possible locations that are being explored to help manage more smoothly the asylum-seekers.
	<u>Greenway Overcrowding</u> : I am working to alleviate the overcrowding on the greenways on the West Side. We've called for taking a lane of the West Side Highway south of 57 <sup>th</sup> Street to use for bikes to reduce congestion on the main greenway.
	<u>COVID Bivalent Booster</u> : The percentage of people who have received the new COVID Booster is far too low. I encourage all members of the Community Board to be health ambassadors and to encourage fellow community members to get the COVID Booster.
