Yiyi Wang from the Manhattan Borough President's Office	<ul style="list-style-type: none"> <li>Thanks to all who helped distribute turkeys and more than 10,000 lbs of produce. Please join our volunteer list if you would like to help with similar efforts.</li> <li>Thanks to all who participated in the Leadership Training Sessions a few weeks ago; they will be available online soon.</li> <li>The current Open Meeting Law is set to expire in July 2024. Our office will host a public hearing on Dec. 14 at 11 am to gather feedback from the public on the benefits and challenges of video conferencing and hybrid meetings, as well as recommendations for how to improve access, participation and overall engagement in local public meetings. All testimony will be submitted to the New York State Committee on Open Government.</li> </ul>

Dana Schmerzler from NYS Senator Krueger's Office	<ul style="list-style-type: none"> <li>• Senator Kruger recently introduced legislation, S.7749, that would strengthen rights and protections for New Yorkers involved in surrogacy or egg or sperm donation. The new bill builds on the framework created by the Child-Parent Security Act, which legalized gestational surrogacy in 2021.</li> <li>• Our office is urging the Governor to support the Climate Change Superfund Act and also to sign the Tropical Deforestation Procurement Act.</li> </ul>
Robin Forst from the Office of the Mayor	<ul style="list-style-type: none"> <li>• Three recent initiatives by the Mayor's Office:               <ol style="list-style-type: none"> <li>(1) NYC is going to be the first city on the East Coast to transition all of its heavy-duty fleet vehicles (appx. 12,000) to be powered by renewable energy sources.</li> <li>(2) NYC will double its rate of making safety improvements to intersections – at least to 2,000 intersections a year. Also, the NYPD will add traffic violence to its regular CompStat reporting — treating traffic safety as a critical public safety issue</li> <li>(3) NYC is launching intensified street outreach efforts to help all New Yorkers living on the streets move to safer, healthier indoor conditions. During the past year, more than 50 of the 100 hardest to reach New Yorkers living on city streets — many of whom are known or believed to have severe mental illness — now have a roof over their heads and are stabilizing their lives in a hospital or another supportive setting. This represents a 145 percent increase over the prior year.</li> </ol> </li> </ul>
Curtis Young from the Public Advocate's Office	<ul style="list-style-type: none"> <li>• The increase in the popularity of e-bikes and electric scooters has led to a corresponding increase in fires and hazards due to faulty technology and unsafe storage and charging practices. The Public Advocate encourages public information campaigns and support to businesses about safety measures to implement.</li> <li>• Our office will host a town hall about the increased use by the NYPD of stop-and-frisk stops in NYC Black and Latino communities. Go to our website to register.</li> </ul>
Eric Strazza from the District Attorney's Office	<ul style="list-style-type: none"> <li>• The DA's Office recently awarded \$3 million to The Fortune Society, an organization that supports reentry and alternative-to-incarceration services, to create a network of Court Navigators that will support New Yorkers with deeply entrenched needs (eg mental health and substance abuse issues).</li> <li>• Our office, alongside State Senator Brad Hoylman-Sigal and State Assemblymember Grace Lee, recently announced a bill called the Hate Crime Modernization Act which intends to expand what offenses are deemed hate crimes, namely by increasing the total range of eligible hate crime charges from 66 to 97.</li> </ul>
Erica Overton from State Assemblymember Rosenthal's Office	<ul style="list-style-type: none"> <li>• Given the number of smoke shops selling illegal cannabis, our office has asked Governor Hochul to increase the number of people dramatically in the enforcement agency – the problem is too big for the agency to remain understaffed.</li> <li>• Our office also wrote a letter asking for clear guidelines for notification of community boards when there will be cannabis grower showcases – there was a showcase in MCB4 but no notification to the Community Board.</li> <li>• As a result of the Adult Survivors Act (the law that created a one-year period for adult survivors of past sexual assault to file a case against their abuser) which our office helped to sponsor, 3,000 people filed cases against their abusers, but some people still missed the deadline. We would like to extend the lookback period an additional year during the next legislative session.</li> </ul>

NYS Senator Brad Hoylman-Sigal	<ul style="list-style-type: none"> <li>• Huge thanks to MCB4 for your help in pushing the State on supportive housing at Bayview, the former women's correctional facility. We are making great progress in large part due to MCB4's vision in connection with that amazing property.</li> <li>• On Dec. 1, Governor Hochul signed into law the bill I introduced (S.1783A/A.372A) which establishes a bill of rights for long-term care facility residents who are lesbian, gay, bisexual, transgender, or living with HIV. The bill prohibits long-term care facilities and their staff from discriminating against any resident on the basis of a resident's actual or perceived sexual orientation, gender identity or expression, or HIV status.</li> <li>• I am very proud of the impact of the Adult Survivors Act, which I co-sponsored with Assemblymember Linda Rosenthal. More than 3,000 survivors were able to file civil claims against their abusers.</li> <li>• Congestion pricing has raised some concerns which we are helping to iron out. For example, if you live in the zone and you leave, you shouldn't be charged as that is "decongestion". We are also helping to address concerns about emergency service vehicles (e.g. Red Cross, In God's Love We Deliver). But at the same time, we have to make sure that congestion pricing is supported and not watered down.</li> <li>• Good news about Midtown Community Court – it looks like funding will be available for services to be provided 5 days a week instead of part-time!</li> <li>• Presented outgoing MCB4 Chair Jeffrey LeFrancois with a proclamation to honor his extraordinary contributions to the community as Chair during the last two years.</li> </ul>
City Councilmember Erik Bottcher	<ul style="list-style-type: none"> <li>• There was a big raid on an illegal weed shop on 10th Ave. recently, but the store re-opened within hours. Getting rid of the illegal sale of cannabis continues to be a huge challenge. My office will support new legislation in early 2024 that is designed to more effectively address this problem.</li> <li>• Together with Councilmember Gale Brewer, he presented outgoing MCB4 Chair Jeffrey LeFrancois with a proclamation to honor his extraordinary contributions to the community as Chair during the last two years.</li> </ul>
City Councilmember Gale Brewer	<ul style="list-style-type: none"> <li>• The cuts proposed to the City budget are outrageous – there are way too many cuts proposed.</li> <li>• I support migrants strongly, but am concerned about the million-dollar contracts without RFP's going to for-profit companies to work with the migrants, so our office is looking into it.</li> <li>• Migrant children should not be forced to move between schools and that's what will happen with the City rule limiting stays in shelters to 60 days. We need a new plan that allows these kids to stay in their schools.</li> <li>• The problems with smoke shops selling illegal cannabis are endless and my office continues to work hard to address them.</li> </ul>
