OC 8th Ave., LLC, d/b/a Olde City Cheesesteak & Brew, is applying for an on-premises liquor license at 201 8<sup>th</sup> Ave., New York, NY 10011. There are currently twenty-one (21) licensed establishments within 500 feet of the proposed location. These licensees are comprised of fifteen (15) restaurants American-style restaurants, (5) tavern/bars, and one (1) hotel.

Located in Chelsea neighborhood of Manhattan, this establishment would replace a prior licensee. The premises features recorded background music, only, and there are no outside areas. As such, sound in the area is not expected to increase beyond the ambient levels. The applicant maintains an Alcohol Security Plan that requires all staff members to be TIPs Certified, and allows for professional security to ensure that no underage or visibly intoxicated individuals are served. The premises will include only one bar, with a total maximum capacity of 90 persons.

The proposed restaurant is accessible by various types of public transportation, including bus and taxi. As such, the impact on traffic is expected to be minimal. In addition, both public parking lots and on-street parking areas are located nearby. For these reasons, as well as others, issuance of this license would serve the public interest.
