RE: Adult-Use Retail Dispensary at 723 Eleventh Avenue - Rezidue LLC

Dear Ms. Reid and Ms. Wright,

Manhattan Community Board 4 ("MCB4"), at it's April 2<sup>nd</sup> 2025 full board, voted, by a vote of 42 for, 1 against, 1 abstaining, and 0 present-not-eligible, to recommend approval of the application of Social & Economic Equity CUARD applicant Rezidue LLC for an Adult-Use Retail Dispensary at 723 Eleventh Avenue.

Rezidue LLC is a 100% woman owned business. Nubia Ashley was previously engaged in the legacy cannabis market. She already has been granted a license and proximity protection for this location from the Office of Cannabis Management. Proximity protection issued by OCM prevents another location from being approved within 1000 feet. OCM will grant an applicant proximity protection that is compliant with all distancing and proximity requirements until a final determination is made on the corresponding application. Ms. Ashley searched for the past few years for a location for her dispensary and with family ties in Hell's Kitchen has settled on the 722 Eleventh Avenue location. Ms. Ashley is currently seeking legal representation. She completed the OCM courses offered to applicants and licensees, has been working at a cannabis dispensary in upstate New York and draws on her experience from the legacy market. Ms. Ashley represented herself and intends to work full-time at her proposed dispensary. Ms. Ashley demonstrates a strong an understanding of the complexity of the OCM regulations.

Rezidue LLC is seeking an Adult-Use retail dispensary license. Adult-Use retail dispensaries are the principal license to conduct retail sales of adult-use cannabis products to consumers over twenty-one (21) years old. Retail dispensaries are allowed to acquire, possess, sell, and deliver adult-use cannabis products from their own licensed premises and licensed distributors, in addition to other select items including paraphernalia. Rezidue LLC will offer in-store and online items with delivery within a 2-mile radius. The Proposed hours of operation are 8am to 8pm Monday through Friday and 11am- 9pm Saturday and Sunday.

The proposed location was formally leased to an illicit cannabis shop. The space is in compliance with all OCM requirements regarding distance away from other dispensaries, schools and houses of worship. However, it is in close proximity to DeWitt Clinton Park, which is of concern for some community members. Ms. Ashley is familiar with the park and frequents this park with her school-age daughter and neighborhood family members. She is committed to working with the community to uphold no smoking rules in parks, as well as offer general education around cannabis.

MCB4 recommends approval if and only if the Applicant agrees to the following stipulations:

- Actively engage with the local Block Associations and other community stakeholders with the aim of solving problems if they arise
- The Applicant will operate the dispensary in accordance with the methods outlined in the applicant's MCB4 Cannabis Task Force application (annexed hereto as <u>Exhibit A</u>).
