Overview slideshow presented by Natalie Mendell. There are three community classrooms that can be used for free if a community group reserves the space. To date, there has been 72% utilization of the space. In 2024 alone, we had 430 community groups and nonprofits use the space.

Shared data about the first month of 2025 and welcomed questions. Said that robberies were up in January, mostly related to shoplifting. Two of our big hotspots are TJ Maxx and Old Navy. The majority of 311 calls are noise complaints.

US Representative Jerrold Nadler, presented by Mackey Bentley	• Congressman Nadler is working hard as the senior judicial member to protect Civil Service employees, the FBI and the Inspector Generals, to name a few. He is also working to protect birthright citizenship and gender-affirming care. He is also closely monitoring ICE activity in NY.									
NYS Assemblymember Tony Simone, presented by Ben Lowenstein	 Assemblymember Simone has a number of new bills, including: in misdemeanor cases where the defendant is found unfit to proceed to trial due to mental illness, they are typically released without treatment, and Simone's bill will ensure that Crisis Intervention teams and other supports are provided at the moment of release prohibiting "greenwashing" of marketing claims, which is when companies use deceptive claims to sell their products and services as more environmentally friendly than they really are. Assemblymember Simone recently released a report to address the interconnected issues of substance abuse, homelessness and mental illness. The report includes goals such as increasing the quality and quantity of Supportive Housing by transferring contracts to modern funding systems; funding full-time nurses and people with backgrounds in Clinical Psychology to be part of Outreach Services; investing in and expanding inter agency hubs; updating the criteria 									

	that allows for people to be involuntarily committed to what is used around the country; making psychiatric beds operational by investing in extended care facilities; and implementing a permanent annual COLA overall base wage increase for and overall base wage increase for Human Service workers.
NYC Council Member Erik Bottcher, presented by Carl Wilson	• The council member sent a letter to the acting Sanitation Commissioner regarding a proposed rule change that doesn't allow bagged garbage to go next to the corner receptacles. This rule would be a big operational challenge for our sanitation partners like BIDS and community groups, because then they would have to haul the trash away that they're gathering for the City. We've asked the Sanitation Commissioner to go back to the drawing board to come up with a rule that makes more sense for our sanitation partners.
	• I want to acknowledge the expansion of the Midtown Hub. The model for this Hub was originated by the District Attorney at 125th Street to deal with chronic quality of life and public safety issues. We have introduced that model along 8th Ave. in Midtown and now expanding into Hell's Kitchen. We also want to acknowledge Delores Rubin on MCB4 and say how glad we are that she is involved with this effort.
