	Reports From Elected Officials
NY State Senator Brad Hoylman-Sigal, presented by Jonah Rose:	 The Senator hosted a Civil Rights Town Hall last week. You can see it on our website. Last month a federal judge ruled that the Trump Administration was unlawfully withholding billions of dollars in federal funding, directly violating a court order. As chair of the Senate Judiciary Committee, Brad is committed to ensuring court orders issued in New York state are upheld. So Brad submitted a formal complaint against Acting Deputy AG Emil Bove to the NY State Attorney Grievance Committee. The Sheddie Awards highlight the worst scaffolding and sidewalk shed abuses and we will be announcing the "winners" tomorrow.

NY State Senator Liz Krueger, presented by Dana Schmerzler:	 This legislative session, Krueger has introduced two bills that are our top priority: New York State Abortion Clinical Training Program Act, intended to train health care practitioners in the performance of abortion and related reproductive health care services, and NY HEAT Act, which would require utilities to provide easy access to the most affordable and healthier heating options for their families
NY State Assemb. Linda Rosenthal, presented by Erica Overton:	 The Assembly Member is hosting a Democracy Town Hall tomorrow night, including panelists from the Brennan Center and the National Institutes of Health Rosenthal has also introduced two new pieces of legislation recently: requiring State Medicaid to cover gender affirming care, no matter what happens at the federal level protecting Librarians from criminal and civil charges who refuse to ban books. The Assembly Member's Data Privacy Bill is awaiting signature by the Governor. It protects private health info on apps from being sold to third parties.
Manhattan Borough President Mark Levine's Office, presented by Erik Cuello	 Thanks to MCB4 member Rachel Lee for sharing the "Know Your Rights" information and helping to spread the word in our community The MBP released his recommendations for Western Rail Yard, which was a disapproval with no conditions, similar to MCB4. The deadline for applying/reapplying to be a member of MCB4 has been extended to March 7, 2025. The MBP will be hosting his State of the Borough Address on March 23 at LaGuardia High School.
US Congressman Dan Goldman, presented by Betsy Schmidt:	 We did a "Know Your Rights" event with the NY Immigration Coalition, and it is available for viewing on our web site and on YouTube. You can also find the Congressman's virtual Town Hall from last month on our web site and YouTube. The Congressman joined 88 of his colleagues in sending a letter to the Trump administration asking for the recision of the Executive Order that is blocking gender-affirming care for trans young people. On our web site, we are collecting stories of people who have been impacted by the government shutdowns and DOGE cuts. We want to collect and share these stories, and also make sure that sharing them won't impact people's federal jobs if they still have them. If you know anyone so affected, please have them fill out the form on our web site.
NYC Mayor Eric Adams, presented by Robin Forst	 The deadline to apply for the Summer Youth Employment Program has been extended to March 14. The Mayor announced yesterday a new program to take care of medically vulnerable homeless people, which will provide for them to go to a medical respite center for up to 90 days after being released

from a hospital (instead of directly into a shelter) and then will help them find more permanent housing after the respite center.
