Security Plan

Security is trained to check IDs of all guests who order alcohol. Any guest who is under 21 or unable to provide adequate ID will not be served.

Staff will have the right to refuse to serve anyone at their own discretion; this may include anyone who is visibly intoxicated or displaying intoxicated behavior.

House of McQueen Traffic Mitigation Plan

The management of the Off-Broadway play titled House of McQueen which will be presented at 508 West 37th St. will have security guards manage traffic outside the location during show nights in order to ensure that ride share and taxis do not park in front of the theater waiting for passengers.

The security guards will monitor traffic and will allow pick-ups and drops offs in the no parking lane which is in front of the building before and after all performances. The no parking lane is in addition to the 2 lanes of traffic.
