# **GMOS**

There are no GMOs in our flour tertifles, corn tortiflas or rice. Our corn chips however do contain GMO corn (90% of the US corn crop is GMO), as do our corn and soy oit.

#### DAIRY

There is zero dairy in anything we self except our cheese and our sour cream. Our cheese is Monterey Jack, and it is naturally lactose free.


