## **Re:** El Cid Restaurant Inc.

174 8<sup>th</sup> Avenue (btwn W18<sup>th</sup> & W19<sup>th</sup> Streets) ALTERATION APPLICATION/LICENSE NO. 1245719

Dear Chairman Bradley:

Manhattan Community Board 4 (MCB4) recommends <u>denial</u> of the alteration application of El Cid Restaurant Inc. to extend its On-Premise license to its adjoining rooftop deck. Given its present illegal use of the roof deck, its failure to honor and abide by its previous agreement with MCB4, the history of complaints with respect to this establishment, and the disruption to the residential quality of life that would be caused by the requested alteration, allowing the alteration would not serve, and would be contrary to, the public interest.

Most significantly, El Cid already has been consistently serving alcohol on its outdoor roof deck despite the fact that, in the Establishment Questionnaire that El Cid submitted to the State Liquor Authority with its initial application, El Cid answered "no" to the question asking "Any outdoor area or sidewalk café used for the sale or consumption of alcoholic beverages? (such as roof, yard, deck)." Having consistently flouted this representation with its illegal alcohol service on its outdoor roof deck, El Cid should not now be permitted to legitimize this practice with the requested alteration to its liquor license -- particularly given the major disruption to reasonable residential quality of life that use of this roof deck has caused.

El Cid has been the subject of multiple complaints from its immediate neighbors and other members of the Chelsea community. It has appeared before MCB4's Quality of Life (QoL) Committee in our attempts to address the community's concerns. Neighbors of El Cid have documented consumption of alcohol on the roof deck on multiple occasions. When confronted with this fact at MCB4's QoL Committee meeting on June 8, 2015, El Cid agreed to not use the roof deck, including previously scheduled events, unless and

But even after this written agreement (a copy of which is enclosed), El Cid has continued to use the roof deck. As of the date of this letter, El Cid's website, http://elcidnyc.com/, continues to prominently advertise its "Private Roof Deck Upstairs." The impact of these actions blasts away any trust the community had remaining in the words of El Cid.

When El Cid presented its alteration application at the July 14, 2015 meeting of MCB4's BLP Committee, many individuals and representatives of nearby block associations spoke against El Cid's application. Others who could not be present sent emails to MCB4's office expressing their opposition. Upon hearing the opinions of the neighbors and confronted with the violations regarding the use of the roof, El Cid had no response, neither denying the activity nor offering any apology or explanation.

Given El Cid's willingness to allow the illegal alcohol consumption on its roof deck, its refusal to adhere to its recent agreement to cease using the roof, and the demonstrated disruption to the community caused by use of the roof, MCB4 believes that any use of the roof would have a serious negative impact on numerous community residents and recommends that the alteration application be denied in its entirety. MCB4 does not believe that the issues with the roof use could be solved by stipulations setting conditions for use of the roof, both because of the demonstrated disruption and problems caused by any use of the roof and because, given its track record, MCB4 has no confidence that El Cid would adhere to any parameters attached to the use of the roof. We conclude that it would not be in the interest of the community to alter El Cid's liquor license.

Thank you for your attention to this application and MCB4's concerns.
