Dear Ms. Reyneso:

Manhattan Community Board 4 (MCB4) recommends <u>denial</u> of an unenclosed sidewalk café permit for 1910 Waterfront LLC d/b/a The Filmore Room:

- The applicant has refused to appear before MCB4 prior to the July 27, 2015 • deadline for MCB4's recommendations on this application to the Department of Consumer Affairs (DCA). MCB4 and the community thus have had no opportunity to discuss the application and its operations with the applicant. Upon receipt of this sidewalk café application from the DCA, MCB4 sent its standard Sidewalk Café Stipulations Application to the applicant and notified the applicant of the upcoming meeting of MCB4's Business Licenses and Permits (BLP) Committee on July 14, 2015, at which the application would be discussed. On July 13, the day before that meeting, the applicant asked to postpone its appearance to the August meeting of the BLP Committee. MCB4 responded that it ordinarily would agree to such as a postponement, but explained the current July 27 deadline for its recommendations and asked the applicant to withdraw and re-file its application so that MCB4 could submit timely recommendations after the applicant's appearance at the August BLP meeting. The applicant, however, both refused to withdraw its application and refused to appear at the July 14 BLP meeting, although it indicated that it still wanted to appear at the August BLP meeting -- after the deadline for MCB4's recommendations.
- Unfortunately, this is simply the latest example of the applicant's refusal to engage in any meaningful discussion with MCB4 or the community. As reflected in the

330 West 42nd Street, 26th floor New York, NY 10036 tel: 212-736-4536 fax: 212-947-9512 www.nyc.gov/mcb4 enclosed June 17, 2015 letter to the NYS Liquor Authority, when applying for its liquor license, the applicant, despite multiple requests from MCB4, refused to submit any information about its planned operations to MCB4 or to meet with MCB4 and the community. Such disregard for the community does not bode well for the applicant's operating a sidewalk café in a manner that takes the community's interests into consideration.

- MCB4 also has concerns about the size and layout of the sidewalk café as reflected in the proposed plans. At 20 tables and 46 chairs, this is quite large café. It is located on avenue corner and immediately below numerous residential windows.
- Although MCB4 urges that this application be denied for the reasons stated above, in the event any permit is granted, MCB4 requests that the café be closed and vacated at the hours that MCB4 requests from all sidewalk café applicants: 11:00 p.m. on Friday and Saturday nights and 10:00 p.m. on all other nights. MCB4 has found that these closing hours are necessary to protect reasonable residential quality of life for community members living above and adjacent to sidewalk cafes.

Dear Chairman Rosen:

Manhattan Community Board 4 (MCB4) requests that the NYS Liquor Authority (SLA) <u>deny</u> the above-referenced application. Despite multiple requests from MCB4, the applicant has refused to submit any information to MCB4 about its planned operations and has refused to appear at a public meeting of MCB4's Business Licenses and Permits (BLP) Committee or otherwise meet with MCB4.

On January 20, 2015, the applicant submitted the standard 30-Day Advanced Notice form to MCB4 and requested that any meeting notification or questionnaire be sent to the applicant's attorney. Following its usual practice, on January 26, 2015, MCB4 sent by email to the applicant's attorney MCB4's standard Liquor License Stipulation Application and requested that it and related information be submitted by January 29, 2015, so that the applicant could appear before the BLP Committee at its next meeting on February 10, 2015.

The applicant did not submit any information by January 29 nor did it communicate with MCB4 in any way beyond the submission of the Advanced Notice form. Accordingly, on February 2, 2015, MCB4 sent the enclosed letter to Dennis Rosen, Chairman, of the SLA informing the SLA of those facts and recommending denial of the application.

Several months later, MCB4 read press reports that a chef named Liran Mezan planned to open a new establishment at this location in May. Mr. Mezan had been listed as the "owner" on the Advanced Notice form submitted to MCB4 on January 20. Mr. Mezan was quoted in the *New York Daily News* on April 25, 2015, that the liquor license would be until 4:00 a.m.: "It was transferred from Moran's [the prior establishment at this location] and that's what they had."

Because neither Mr. Mezan nor his representatives had had any contact with MCB4 since the submission of the Advanced Notice form in January, the Chair of MCB4, Christine Berthet, on May 13, 2015 reached out by phone and by email to the applicant's attorney, Joseph Levey, asking that the applicant complete MCB4's standard Liquor License Stipulation Application and appear before MCB4's BLP Committee at its next meeting. Despite agreeing -- in two separate emails dated May 13, 2015, and May 22, 2015 -- to submit the requested information to MCB4, Mr. Levey to date has submitted none of the requested standard information to MCB4, and the applicant has not met with MCB4. Mr. Levey is no longer returning our calls.

MCB4 has serious concerns about an On-Premise license until 4:00 a.m. in this very residential area. The former operator typically closed at 11:00 p.m. to midnight. MCB4 would like to discuss the method of operation and evaluate possible safeguards to preserve the quality of life for the residential population.

Accordingly, given this failure of cooperation and the accompanying lack of information about the applicant and its planned operations, MCB4 recommends that this application for an On-Premise license be <u>denied</u>.

As it has since the start of this process, MCB4 urges the applicant to submit the standard information requested of all applicants and to meet with MCB4 about its method of operation. If those events occur, MCB4 will reconsider its recommendation of denial.

Thank you for your attention to this matter.
