# **Public Session:**

Toni Knox, community resident, speaks in support of Bamboo 52. She complains about people that complain about noise. She says we live with noise.

Gary Gosgrove, President of Imperial Court of NY, expressed support for John Greco and Bamboo 52. Many members of the audience applauded in approval.

Daniel Doohan sought support for his SLA application (item 11) for his new restaurant Dan Doohan's at 733 9th Ave, handed out letters of endorsements. He has experience running bar/restaurants in other districts and intends to live above the restaurant. Doohan's Architect rose in support of Doohan's restaurant at 733 9th av. Rob Bookman, Attorney for Doohan, says applicant altered plans as per committee views.

Kevin Kitchen, 101 W23 St., lives in a coop building, seeks CB4 assistance with Landlord-Tenant dispute. Problem is related to ground lease; says landlord is not negotiating in good faith.

Patrick Hines, resident of Clinton for 15 years, supports Daniel Doohan's Restaurant. Highly recommends SLA application.

Several other members of the public expressed support for Daniel Doohan's restaurant.

Lynn Bloch supports Dan Doohan. She has lived at 33 W56St for 15 years. Kieran Green rose in support of Doohan.

Mike Camenzuli, 404 50 St, supports Doohan. Says Doohan plans to live in the building. He will be owner/operator.

Amy Groschel, representing Ars Nova Theater at 54St between 10/11, left brochures.

Nicole Renzler spoke in support of Bamboo 52.

Jackie Brown, supports Bamboo 52, doesn't understand why noise is considered a nuisance; blame cannot be placed on one establishment alone.

Sherry Porter supports Bamboo 52.

Laura Stein lives on same block of and supports Bamboo 52. She gets home late and says there is no healthy place to eat at night except Bamboo 52.

Various additional members of public expressed support for Bamboo 52 and agree with previous positive comments.

Syd Ziegler, founder of NY Gay Football League, say John Greco /Bamboo 52 supported the founding of the League and is a strong supporter of the League. Zeigler supports Bamboo 52.

Molly Lenore, Commissioner of NY Gay football League, supports Bamboo 52.

Regla Fernandez, Mike Wong support Bamboo 52.

John Greco, owner of Bamboo 52, says he took steps to address committee concerns. He is hiring security staff, has installed ash tray receptacles outside, removed front benches, and took various steps to reduce noise.

Attorney for Bamboo spoke on behalf of his client.

Marilyn Sirasky, longtime resident of W45 St., presented a letter representing a major number of people in the community: Presidents of W46, W48 St block Associations, concerning the over saturation of bars in neighborhood. Urges CB4 to address this concern in SLA applications, and to consider 500 foot rule.

Mariette Bolitsh supports Bamboo 52. Jesus Gonzalez, expressed support for John Greco and Bamboo 52. Luis Gonzalez spoke in favor of Bamboo 52 Jimmy Lyons, John Dempsey - support Dan Doogan

Ashley, representing W44 St Better Block Association, is concerned about over saturation of bars in the neighborhood.

David Glasser is against the strip club at 565 W23rd St. He says that zoning law does not allow adult establishment at the site. (says zoning is M15/R9A).

Darrick Sampson, VP W46 St Block Association. Dirk McCall, Executive Director, Chelsea Chamber of Commerce, supports John Greco.

Christine Berthet, announced a traffic study to cover 8th Ave to the River, and 55 to 29 St. The purpose is to reduce congestion. Interested parties should attend a meeting on Wed Apr 30, 6-9pm, Holy Cross School, 332 W43St.

Ron Zacchi spoke in support of John Greco and Bamboo 52.

Father Peter Colapietro, Pastor of Holy Cross Church W42St, between 8/9 Avenue, speaks on behalf of Dan Doohan. Says Doohan was a great addition to the neighborhood at prior establishment: Murphy's. Encourages board to recommend approval of SLA application.

Sean Burger favors application for Hibernia, 401 W50 St. (see item #5)

Celine Ward supports Bamboo 52, works next door at the post office.

### **Report from Elected**

Mike Kent, representing Borough President Scott Stringer, congratulates new Board appointees. Kent says the Borough President (BP) favors congestion pricing. Tomorrow will be first meeting of Construction Watch working group. BP will host Speaker Quinn at Pedestrian Town Hall; Transportation Commissioner will be guest speaker. Its now our job to help shape Moynihan project.

Colin Casey for Tom Duane congratulates MTA Tishman/Speyer, but much work still needs to be done on the plan. The office supports amending demolition clause (legally defines how landlords that intent to demolish can evict tenants). They submitted testimony and letter of support for amendment.

Shannon Flaherty, representing State Assemblyman Richard Gottfried, discussed involvement with Moynihan Station, the Hudson Blvd RFP.

Weinberg, Assemblywoman Linda Rosenberg, says Rosenberg has known the new governor, Paterson, for a long time, as they served together in Albany; looks forward to working Crane Safety; reached out to Dept of Buildings, which needs better regulations; supports congestions pricing, and supports a Bill to end vacancy decontrol.

Melanie LaRocca, representing Speaker Christine Quinn, expressed concern about Department of Educations (DOE) budget. Speaker supports congestion pricing; sent letter to Dept. of Aging with concerns about modernization plans and how the RFP process is being rolled out. DOE has streamlined pre-K application process. NYC Dept. of Youth and Community Development has put out 2008 summary youth applications. Construction site safety hearings are to be conducted at the end of April.

# Bob Benfatto, CB4 District Manager Report

621 W46 St (across from Pasha), failed 500 foot rule at hearing (vote was 1 to 1). 8% budget cuts affecting Community board office. Program to eliminate Gap (PEG) is looking for \$26K of savings at the office. Robles suggests that the office email packets instead of use postal mail. Many members express interest in receiving email packets.

## Report on NYU

Burt - Community Task Force for NYU Development (see <u>www.communitynyc.org</u>) adopted a series of expansion principles for development of NYU properties, as a guide with future negotiations with NYU.

Brett – says he hopes this doesn't become an issue with CB4.

Renee Schoonbeek, CB4 Assistant District Manager, gave a presentation on CB4's website. <u>www.communityboard4.org</u>. Renee talked about the website today, things to improve, and how website will appear in the future; urges people on phone to go to website. The website provides access to monthly newsletter, calendar/archives, license information, overview of sidewalk cafes, information about business and license numbers. A goal is to build a database of affordable housing in the district.

NYC Council Gayle Brewer, in person, says Community Board 7 is happy with Dewitt working on website; supports Congestion Pricing; Budget – wants no cuts to schools in classroom; upset about RFP at Dept for Aging; doesn't want to close centers; Thanks to Chair and District Manager, Friends of Environmental studies High School students would like to maintain green street on W50 Sts. She supports students in their quest to maintain green street on their block.

Nations school request for IDA bonds are tied up in Albany - this will be tougher in this budget.

Lee Compton, speaking as Chair of Nominating Committee, says Committee met twice during the month of March; next month will provide a slate of candidates for elections in June meeting; each incumbent has expressed interest, including the secretary. Borough President has done a good job in getting activist people; anyone interested in standing for election should talk to Lee or any committee members. Bylaws state that there can be nominations from the floor.

Jay Marcus spoke in opposition of his committee recommendation defeating Doohan bar. Jay moves to put alternative letter, worded as "denial unless" with stipulations. Anna Levin opposes bar on grounds of over saturation. The difference here is that this is a new license, instead of the transfer of an existing license. Morgan supports bar. Tony supports license. A member expressed concern about overly strong language coming out of BLP committee. Trend is reverse form last year. Mike Mazier speaks in support of Doogan, states that economic forces make the bar viable; in this case we have an owner that will live over his own bar. Allen Roshkoff supports Jay's amendment and thinks we should take into consideration entire circumstances; we are supposed to care about economic development. Jay's amendment includes: reduction to 175 patrons, stipulates security, sound proofing.
