PUBLIC HEARINGS

ULURP #: N100068 ECM: an application for an enclosed sidewalk café (6 tables/12 seats) at Merchants NY, 112 Seventh Avenue (17th Street).

Pamela Wolff is opposed to the enclosed sidewalk café as it is now due to its current size. If the present size could be made smaller she would be in favor. That was the only public citizen who spoke about the ULURP.

Public Session

Adam Myerhoff spoke on behalf of the Census Bureau who are currently hiring for the 2010 Census both full time and part time jobs.

Jenna from the Manhattan DA's Office announced the new Deputy Director for Community Affairs, Leona Davidson.

Chairman's Report

Chairman, John Weiss yielded to Lee Compton to report on the Hudson Yards agreement. Lee said that though he was somewhat disappointed about the total number of affordable housing units, the team that included Joe, Sara, and Elisa had accomplished the preservation of approximately 1700 units of permanent affordable off site housing. Also the final plan for the development includes more open space with public use and accessibility clearly defined and a school to be constructed in the first phase.

Appointed Paul Seres new co-secretary to replace Tony Juliano who had to resign because of a change in residence.

A newly created task force is monitoring the CB4 website to ensure changes are being implemented; and to suggest additional improvements.

Announced that he will be meeting with the Commander of Midtown South to discuss the investigation of the alleged anti-gay bias incident outside a bar on Ninth Avenue in the fall and the possible failures of the reporting process.

Elected Officials' Reports

Seth Berliner for Senator Tom Duane reported on the budget changes. Announced the Senator did not want to cut budgets for health benefits. Modified or rejected 75% of the Governor's proposed health cuts.

Sandy Myers from Borough President's Office spoke of the efforts for Community Board recruitment.

Jeffrey LeFrancoise spoke for Assemblyman Gottfried and congratulated the success of the WRY moving forward.

Greg Monte representing Assembly member Rosenthal not happy with the MTA to cut the student metro cards as well as access a ride to the elderly and disabled.

Melanie LaRocca for Speaker of the City Council Christine Quinn. Announced a social networking campaign for HIV/AIDS awareness.

District Manager Bob Benfatto announced that meetings originally scheduled on January 18th, which is MLK day, have been moved, CPP is now on the 19th and Quality of Life is now on January 21st.
