Dear Officer Gentile:

Manhattan Community Board No. 4 has received numerous complaints regarding trucks using West 16th Street as a through street even though it is clearly marked "No Trucks Except Local Deliveries." Truck drivers exit off the West Side Highway onto 16th Street, which becomes a predominantly residential street after crossing 8th Avenue, to avoid the congestion on West 14th Street. This has created a problem for residents due to the noise, exhaust, and vibration emitted by the trucks.

We understand that enforcement units often cannot issue tickets to truck drivers who use this street as they could conceivably be making "local" deliveries to surrounding blocks. However, as West 16th Street (b. 7th/8th) is still problematic for residents, the Board is requesting greater enforcement on this block, as well as increased attention to enforcement of "no trucks" regulations throughout our District. The Board has submitted a letter to the Department of Transportation requesting a change in signage from "No Trucks Except Local Deliveries" to "No Trucks Except Local Deliveries This Block," to allow for greater enforcement on 16th Street, between 7th and 8th Avenues.

In order to better understand the extent of your enforcement of "no trucks" regulations, the Board respectfully requests that you share with us the records of how many tickets have been written for violations of "No Truck" regulations in our District during the past 12 months.
