Dear Commissioner Kelly:

Manhattan Community Board 4 (CB4) is requesting a meeting with concerning the timing of the police actions that took place on June 27, 2008, the Friday of LGBT Pride Weekend. Planned and implemented citywide, the timing suggests at best a benign indifference to the feelings and concerns of the LGBT community, and at worst the existence of an unexamined institutional homophobia within the NYPD.

Two of the targeted clubs, Marquee and Pacha, located in Chelsea and Hell's Kitchen/Clinton, were closed for the entire weekend forcing signature Pride events, which had been planned long in advance, to scramble for other venues. One of these was a crucial fund-raiser for Heritage of Pride, the community based organization sponsoring the weekend's major public celebrations. The third club, Splash, situated a few feet to the east of CB4's Sixth Avenue boundary, was temporarily closed and customers were not allowed to enter or leave during the inspection.

Residents of New York City and its suburbs, as well as tourists here for the LGBT events, received an unwelcoming message. Ironically, Pride Weekend memorializes the 1969 police raids on the Stonewall Inn and the immediate riotous reaction which gave birth to the modern LGBT rights movement. It also celebrates the contemporary identity, strength and achievements of the LGBT community. The closing down of two important Pride venues and the

mid-evening inspection suspending activities at another venue created an atmosphere of intimidation and suspicion reminiscent of that of 1969.

CB4 is neither questioning the appropriateness of legitimate inspections nor the enforcement of city and state law/code. Indeed we are grateful for exemplary work performed by the NYPD, most noticeable to us through our local precincts. Rather, we are expressing our serious concern over the timing of the actions taken by those under your command who, working with other city agencies, disrupted LGBT Pride Weekend, We are asking for a meeting with you to discuss the issues we have raised.
