**Re: Tenth Avenue Bench Locations** 

Dear Commissioner Forgione:

Manhattan Community Board 4 appreciates the opportunity to request locations for benches along sidewalks. We believe that these 3-seat metal benches will enable a more enjoyable street experience for residents in our district. We are providing suggested locations in Hell's Kitchen this month and will recommend locations in Chelsea next month.

All of the recommended locations are along Tenth Avenue or in the "canoe park" on W. 36<sup>th</sup> Street between Ninth and Dyer Avenues, scheduled for installation this spring. Ninth Avenue and Eighth Avenue are unfortunately too congested to enable even community friendly and useful street furniture such as benches.

We recommend eight (8) locations on Tenth Avenue in Hell's Kitchen for bench placement. These locations were selected based on the availability of sidewalk space, its location near locations with a percentage of senior residents, and/or appropriate for sitting locations. The property owners for the building adjacent to these locations have all approved of the bench placements.

The suggested locations are:

## West Side of Tenth Avenue

601 Tenth Avenue (just south of W. 44<sup>th</sup> Street)

645 Tenth Avenue (just south of W. 46<sup>th</sup> Street) 657 Tenth Avenue (between W. 46<sup>th</sup> and W. 47<sup>th</sup> Streets)

665 Tenth Avenue (just south of W. 47<sup>th</sup> Street)

701 Tenth Avenue (just south of W. 48<sup>th</sup> Street)

735 Tenth Avenue (just south of W. 50<sup>th</sup> Street)

## **East Side of Tenth Avenue**

646 Tenth Avenue (just south of W. 46<sup>th</sup> Street) 662 Tenth Avenue (between W. 46<sup>th</sup> and W. 47<sup>th</sup> Street)

We are also attaching a map with the locations along within the canoe where we request benches.
