Manhattan Community Board 4 (MCB4) recommends <u>denial</u> for an alteration of an On-Premise Liquor License for 733 Restaurant Corp d/b/a Gossip – 733 9<sup>th</sup> Avenue (49/50) <u>unless</u> the following stipulations, agreed to by the applicant, are part of the method of operation for this establishment with a capacity of 174, with 63 tables with 150 seats, 1 service bar and 1 stand up bar with 20 seats.

- Doors and windows must be closed at 10PM Sunday-Thursday and 11PM Friday & Saturday and whenever amplified sound is used.
- Sandwich board and sidewalk signs will be removed/flush to wall.
- For corporate change as well
- > Open till 4AM and kitchen open as well.
