## Dear Chairman Rosen:

Manhattan Community Board 4 (MCB4) recommends <u>denial</u> of new On-Premise Liquor License for Café De La Musique at 510 West 27<sup>th</sup> Street <u>unless</u> the following stipulations, agreed to by the applicant, are part of the method of operation for this establishment with a capacity of 350 people.

The following are the stipulations:

- 1. Applicant agrees to hire, and follow the recommendations, of a certified sound acoustician, to help maintain and mitigate sound;
- 2. Applicant agrees to follow all MCB4 guidelines re use of rear yards space and rooftops;
- 3. Applicant will have a representative attend the 10<sup>th</sup> Precinct Community Council meeting, as well as other relevant community meetings;
- 4. Applicant agrees not to have any door charge for admission unless it is for charitable contributions to a not-for-profit or for political fundraisers;
- 5. Applicant will work with MCB4 and hold job fairs for local residents;
- 6. Queuing will be inside;
- 7. The freight elevator will be converted to a passenger elevator; and
- 8. There will be seating for 80% of the 350 capacity.
